

OPTIMAL INTEGRATIVE HEALTH - by the Murrays PRIVACY POLICY AND TERMS & CONDITIONS

I understand that coaching is a broadly inclusive process that may include different areas of my life including and not limited to health, professional or family relationships and work. I acknowledge that it is my decision and choice how to utilize information in these areas in coaching sessions. It is my responsibility.

1:1 CALL CANCELLATION, RESCHEDULE AND NO SHOW POLICY:

If your program includes a 1:1 call, this service requires 1 (one) business day notice to cancel or reschedule the 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. If you do not show up for that scheduled session you will forfeit the session and will not be able to rebook it.

PROGRAM FEES: If the Client misses a payment the Client will have 5 business days to bring their account into good standing after the declined or missed payment. If the account is not brought into good standing within 5 business days, the Client's Program will be put on hold and access will be denied until the account is brought into good standing. No refunds, withdrawals or cancellations of any kind will be issued for the Program, including deposits, or any partial payments.

MONTHLY PAYMENT PLAN POLICY: If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in any of the Murray Method plans. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

DECLINED PAYMENT POLICY: As a client in any of The Murray Method Programs, you are required to complete all of your payments. You have 5 business days from the date of the payment decline to bring your account into good standing. Failure to bring your account into good standing may result in denied access to your content hub and coaching.

LIFETIME OR ONGOING ACCESS POLICY: You have ongoing access to the The Murray Method To Stop Diabetes In Its Tracks program content hub. That means that after your program timeframe is complete, you will retain access to the content hub and any updated information that may be added. After your program timeframe is complete, you will be removed from the program Facebook group and access to coaching will cease. NOTE: If your program included 1:1 coaching, any unused 1:1 coaching calls will no longer be available for use after the program timeframe is complete.
